

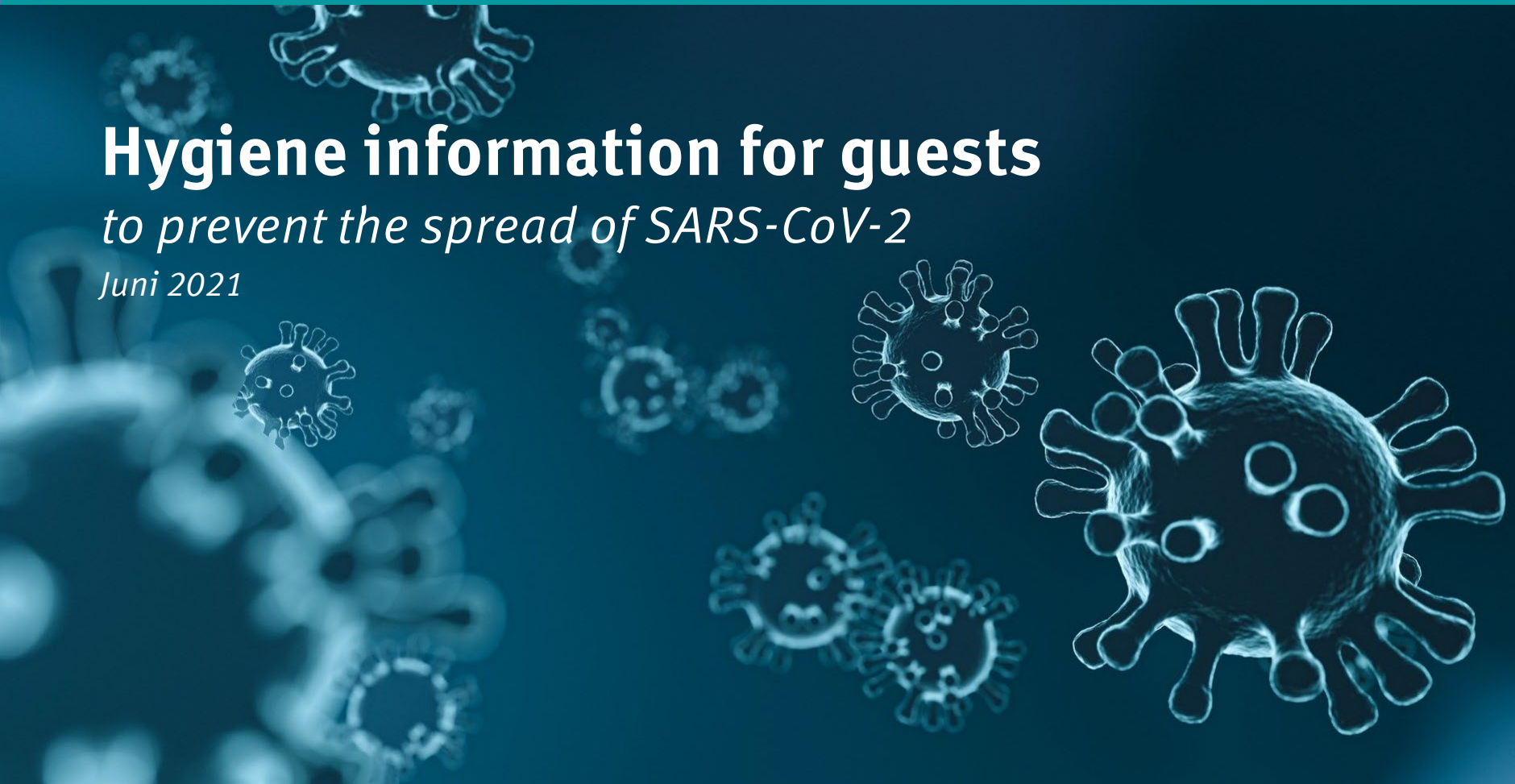

Hygiene information for guests

to prevent the spread of SARS-CoV-2

Juni 2021





On the basis of a comprehensive hygiene concept and the optimization of the processes in terms of infection protection, we are very happy to welcome guests in our house again! On the following pages, we would like to inform you about changes in familiar processes in our facility and ask you to support us by actively participating in our hygiene concept.

The “System of traffic lights” provides a framework for the operation of the educational institutions in Thuringia

Three-step plan depending on the corona outbreaks is as follows:

1. Regular operation with preventive infection protection (GREEN)
2. Limited operation with increased infection protection (YELLOW)
3. Arrangement of a protection measures according to § 28. 1, Sentence 2 IfSG (RED)

- *As of June 2021, the EJBW will implement the requirements of infection protection in the context of stage 1 "Regular operation with preventive infection control" (GREEN) and, as a rule, the technical recommendation of the TMBJS*

On arrival and during your stay, please note the following rules:



- *Please arrive without any symptoms of fever/cold.*
- *Please bring enough masks with you. If necessary, you can also get masks at the reception (at your own costs).*
- *The date, time and contact details of all guests are recorded in a list in order to keep necessary tracking of the Corona chain infection.*

Please keep the safety distance of 1.5m!



- *Please pay attention to the path markings & signs: Keep your distance in foyer, at the reception, in the hallways and paths between buildings.*
- *Please cover your mouth and nose as soon as you enter the building and when you move around.*
- *Cross-group gatherings are prohibited. Please stay in your fixed groups. A separate group room is available for each group. In accordance with the hygiene concept, outdoor activities are preferred over the indoors.*

Cleaning & disinfection are done regularly:



- *Public toilets and critical surfaces such as doorknobs, handrails etc. are checked and cleaned daily. We ask you to use the sanitary facilities in the guest rooms.*
- *Disinfectants are placed at the entrance and / or in the public toilets.*

Work during seminars is only possible within the “fixed group” structure.



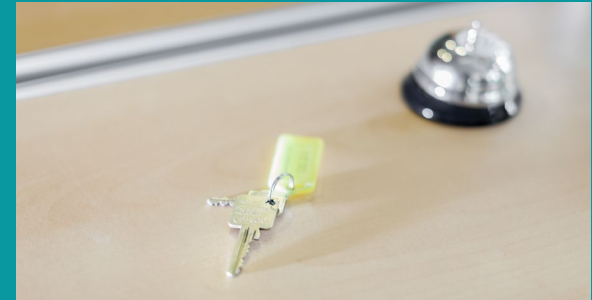
- *Seminar rooms must be ventilated regularly.*
- *Unless they are occupied by fixed groups, the seminar rooms are only occupied by the maximum number of participants, depending on the size of the room, in compliance with the requirement of 1.5 m.*

In the dining room we offer buffet with extensive hygiene measures.



- *The distribution of food and the buffet in the cafeteria are only permitted in the "one-way system" provided that the safety distance is maintained.*
- *All the servings take place in the cafeteria. The tables are set up so that meals can be taken in fixed groups at the previously agreed meal times. Tables are marked according to the groups. Meals are limited to max. 45 minutes (including service and cleaning).*
- *Please wear the mouth and nose cover when moving around the cafeteria and use the disposable gloves for self-service at the buffet.*

We offer you the place for overnight:



- *Currently, the guests are usually accommodated in double rooms each with its own bathroom.*
- *Please ensure that your room is regularly ventilated.*

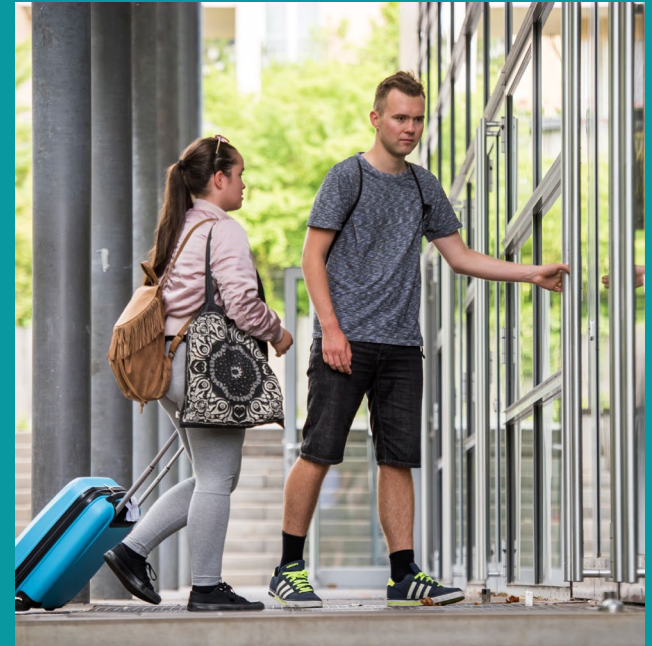
